7 Review of Performance

The Group's turnover in first half 2008 was S\$179.3 million, a 6.4% decrease from the same period in 2007. This was due to weaker sales in the Industrial Materials sector especially for Petrochemical products and the weakening of the US dollar.

The profit after tax for the first half of the year was S\$0.9 million compared to S\$3.0 million in first half of 2007. Included in the 2007's profit after tax was a return of capital in an investment of S\$1.6 million.

Turnover for Building Materials & Security Solutions sector improved by S\$10.5 million to S\$22.8 million (in comparison with S\$12.3 million in the first half of 2007). The operating profit, at S\$0.8 million, was marginally better than the same period in 2007.

The Industrial Materials sector recorded a lower turnover by S\$37.6 million to S\$74.9 million in the current reporting period as compared to the same period in 2007 at S\$112.5 million. The reduction in turnover was mainly due to the weakened sales in some Petrochem products which was offset by improved performance in Plastics both in price and volume. The operating profit for first half 2008 was S\$0.1 million as compared to S\$0.9 million in the same period in 2007.

Turnover for the seafood and coffee businesses within the Agri-business & Foods sector for first half 2008 was S\$14.7 million; marginally reduced from the S\$15.0 million achieved in the same period in 2007. However the operating profit for the current reporting period was S\$0.6 million as compared to an operating loss of S\$0.2 million in same period last year. This was due to higher interest costs in 2007 to support the growth of the new seafood and coffee business.

Turnover for the Semiconductors sector was S\$62.0 million in first half 2008 as compared to S\$48.2 million in the same period last year. The increased sales was mainly from channel sales through aggressive promotions and incentives supported by our principal, AMD. The profit margin for first half saw a dip with the intensified competition for market share due to difficult market conditions. The sector generated an operating profit of S\$0.5 million for the period, representing a 66% reduction from 2007's S\$1.4 million.

9 Prospects

The Group's performance in the 2nd half of 2008 may be affected by continued competition in the semiconductors industry, volatile oil prices, weakness in the US\$, and fluctuating commodity prices. However, the Group will continue to strengthen its selected businesses and market coverage.

No final dividend was recommended for the present financial period.
